### Terms of Appointment & posting:

The appointment for the above mentioned post will be purely on contractual basis initially for a period of 1.5 (One and Half) years from the date of joining (which can be extended at the discretion of the Bank). The selected Candidates will be posted at the Bank's Head Office in Guwahati however; they will be required to undertake job related travel to various places in the state of Assam as and when required.

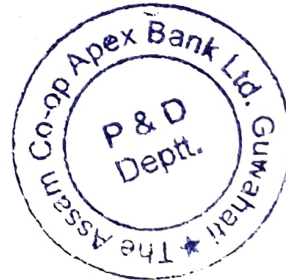
3. Mark sheets of all educational qualifications.
